The general meeting of SMC of I.T.N.Gen School held on 24/03/22 and most of the members were present.

The SMC has approved below mention key points keeping in view the guidelines of fee regulation Committee laid by State Government and by other recommendation of Parent's.

Few key points are given below.

1. That the school cannot hike fee more than 8% in gross fees compared to previous session. So it recommended that fee hike must be less than cap fixed by Government.
2. That the school will not change student's uniform at least for 3 years.
3. By the recommendation of society member's , it has been decided that 25% fee concession should be separately given parent Child. i.e Father Less/ Mother Less.
